COURT PROGRAM HIGHLIGHT

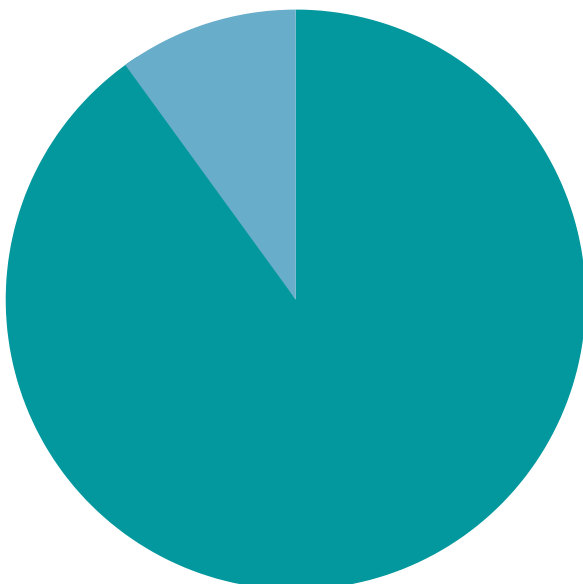
CCC provides court accompaniment and protective order assistance to local survivors. Our advocates attend every protective order docket in each county. We also attend McGirt docket, CFR (federal court) and Mental Health Docket. Many times survivors have been isolated from their support system. It is intimidating to have to go to court and stand across from the person that abused them. CCC Advocates often provide a sense of comfort to clients who would otherwise have to attend hearings and find answers to their questions on their own. Legal services can be imperative to ensure victim/family safety.

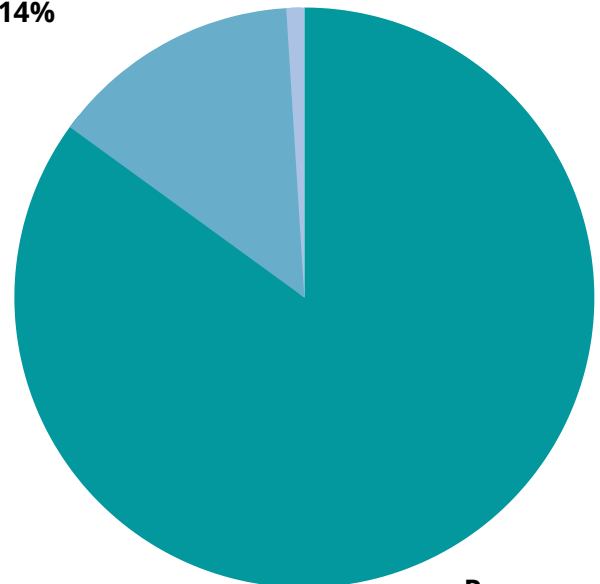
